## **Membership rights and election to Board of Trustees**

Mind in Harrow Trustees are put forward for election at our AGM usually held in December each year, following nomination by two members.

Any member of Mind in Harrow has the right to nominate a person for election to the Board of Trustees, and can do this through our nomination form, available from the Mind in Harrow office. The nomination requires the signature of two members to be accepted.

Candidates for election must be eligible under the Companies and Charities Acts and must sign a declaration that they are not disbarred from standing. They will also be subject to a DBS check.

Nominations should be received at least 21 days prior to the AGM, and candidates will be interviewed by current members of the Board to assess suitability for the role.

All members of Mind in Harrow are entitled to one vote at the AGM, and elections to the Board will be decided on a show of hands of those present at the meeting in accordance with the Memorandum and Articles of Association.
